### **Responsibilities of the Proposer and Seconder (to the Club and the Applicant):**

Please consider proposing a new member carefully, particularly as you will take on important responsibilities both to the Club and to the applicant. The Proposer and Seconder;

1. Must be current financial members and be member of a category that forms the General Body of Members.
2. Should know the applicant personally for a minimum of two years thus ensuring their suitability for membership. Business and social aspects are important to ensure that the applicant will fit easily into the golf and social environments of the Club.
3. Must ensure that the Applicant understands the financial obligations of membership. By lodging an application the Applicant acknowledges the initial financial obligation including any Entrance Fee, together with any future fee increases, without hardship or embarrassment.
4. Should the application be approved, the Proposer may be required to attend the Membership Induction Meeting of the nominee. (Should the Proposer be unavailable, the Seconder may be required to attend).
5. Should the applicant be successful, the Proposer is required to make it their personal responsibility to introduce the new Member into the golfing and social activities of the Club. Furthermore, the initial responsibility rests with you for the conduct of the new Member introduced.
6. Applicants will be required to pay the entrance fee applicable at the time of being admitted to the Club. The Membership Committee wish to make clear to the applicant that this entrance fee may be different from the date of application.

**In Conclusion:** *As the Proposer or Seconder, should you have any concerns, if there is any doubt in your mind, or if the Applicant is of short-term acquaintance, your strong consideration should be given to the proposal of this application. In making your decision, the Clubs best interests should be of priority, keeping in mind that the applicant is being introduced to the Club on your recommendation.*

### 3. PROCEDURE FOR THE PROPOSAL OF NEW MEMBERS

1. This form must be completed in all aspects prior to proposal for membership of the Club being considered.
2. Once completed, it should be submitted to the Club office and accompanied by a \$25.00 application fee. This will be credited against your Entrance Fee should your application be successful.
3. Your application will be displayed in the Club for a period of seven (7) days prior to consideration by the Board of Directors.
4. After this time, you will be notified in writing that your application and deposit has been received along with the date of the next scheduled Membership Interview with a Board Member or Management. These usually take place every 1-2 months.
5. After this interview, the Board will then consider your application for Membership.
6. A letter will be sent by the General Manager or Secretary advising you if your application is approved by the Board of Directors. If approved, the letter will also contain an invoice for payment of any applicable Entrance Fee, the Annual Subscription and any other charges or levies applicable.
7. Upon payment of such fees, the applicant will become a Member of the Club and you will be issued with a Membership Tag. If within one month of such request, the relevant fees are not paid in full, the election to membership shall be null and void and any prior payments made shall be retained by the Club.

5. That the applicant's personal details may be forwarded to sporting bodies for the purpose of affiliation and are held on the Club's database for the purposes of servicing of notices and to comply with the Liquor Reform Act.
6. To provide consent for The Eastern Golf Club or their contractors to use the applicants personal information so they can send newsletters or other material to the applicant.
